It is a **well-established**, **plural and dynamic higher education centre** that plays a key role in the **heritage and culture** strategy of the URV's Campus of Excellence Southern Catalonia.

In line with the Internal Quality Assurance System (IQAS), the Faculty of Arts is firmly committed to training, research and knowledge transfer. According to the U-ranking, the Faculty also offers several highly rated bachelor's degrees with the highest scores in their ambits.

As is indicated in the process *PR-FLL-001 Creation and review of a quality policy and objectives,* in its session on 18 March 2025, the Faculty Board ratified the current policy.

The **mission** of the Faculty of Arts, as part of a leading institution in the creation and transmission of knowledge, is to train professionals in the Humanities and Social Sciences.
